AND Whereas, with the passing years both of the founder and managing trustee named Mrs. Punam Kumari and Mrs. Aprajita Singh as per the supplementary deed dated 11.01.2020 has desired to resign from the Trust Deed due to pre-occupation in the other assignment and since the place in the Trust Board shall fall vacant consequent to leaving out of Mrs. Punam Kumari, D/O Sh. Vishwanath Prasad Singh, R/O C-164 Apartments, Mayur Vihar, Phase-1, Delhi-110091 and Mrs. Aprajita Singh D/O of Mr. RP Singh, R/O A/35 Police Colony, Anishabad, Patna 800002, Bihar, certain clauses need to be incorporated and modified in order to ensure continued growth and proper administration of the Trust.

Accordingly, the Board of Trustee vide Resolution dated 07th October, 2024 has approved certain amendments to the Trust which inter-alia, relate to appointment of Trustees, number of Trustees, Management of Trust etc.

AND WHEREAS, the Founder and Managing Trustees wish to reduce the amendments approved by the Board of Trustees as set below :

NOW THIS DEED OF AMENDMENT WITNESSETH AS UNDER:


I. Two new Trustee has been inducted and the two old trustees have resigned and now, the total number of trustees are two who are the following:-

2. Clause 4 (i) related with Management of Trust of the Trust Deed dated 02.03.2016 as amended vide supplement deed dated 11.01.2020 that is substituted by the following:-
The management of the TRUST shall vest in the Board of Trustees comprising the following persons: - (i) Mr Amrendra Singh, and (ii) Mrs. Alka Singh.

3. Clause 4 (ii) be added with Management of Trust of the Trust Deed dated 02.03.2016 as amended vide supplement deed dated 11.01.2020 substituted by the following:-
The Founder and Managing Trustees shall hold the office of President & Vice President in rotation for three years each shall be member for lifetime.

4. That all other clauses of TRUST DEED dated 02nd March, 2016 as amended vide supplement deed dated 11.01.2020 shall remain same and it is made clear that from now onwards, all the above mentioned two TRUSTEES shall be treated and considered as "Founder & Managing Trustee".

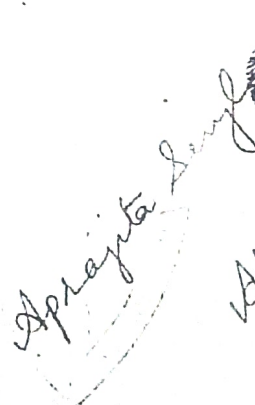

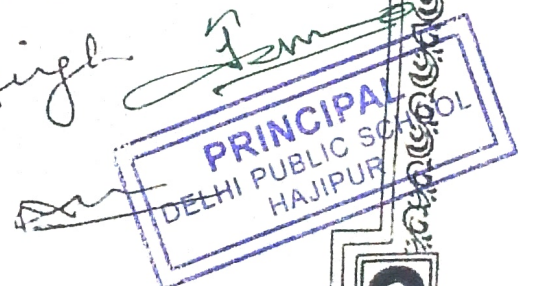
